

## AGREEMENT FOR SUPPLY OF FUEL OIL

**ALDERNEY ELECTRICITY LIMITED** (*Hereinafter called "the Seller"*) agrees to supply to:-

(*Hereinafter called "the Buyer"*) and the Buyer agrees to take from the Seller all his requirements of Fuel Oil as follows:-

**1. PERIOD** - This Agreement shall be deemed to commence on..... **20** and shall continue in force until terminated by either party giving the other one calendar month's notice in writing.

**2. GRADE AND QUANTITY**

(a) The Grade of Fuel Oil is Gas Oil/Kerosene

(b) The quantity provided for in this agreement is minimum 500 litres which is the estimated quantity to cover one delivery which is part of the Buyer's annual requirements of Fuel Oil.

**3. DELIVERY POINTS, METHODS AND PRICE** - The delivery point and method of delivery thereto as at the commencement of this Agreement are to be as follows:-

(a) Into the Buyer's properly vented Bulk Storage Tank at his premises during normal working hours.

(b) Price as at time of delivery to Buyer's Storage Tank.

At the premises of the Buyer, the Buyer will provide a receiving connection for his Storage Tank consisting of a 1" B.S.P. valve with a short length (approx 6") of 1" B.S.P. screwed pipe to receive the Seller's flexible hose connection. The position of the receiving valve and pipe to be within a few feet of a hard road suitable for the suppliers' delivery vehicle.

**4. PAYMENT**

Payment relating to each delivery of Fuel Oil hereunder shall be made net cash within Fourteen days. Credit is only granted on condition that payments are made accordingly, and the Seller may require the buyer to pay cash before delivery. **Title of goods does not pass until full payment has been received.**

**5. MEASUREMENT**

The Seller's metered measurements of quantity shall be accepted by the Buyer, but the Buyer may be represented at the taking of these measurements.

**6. LIMITATIONS ON USE**

The Fuel Oil supplied under this Agreement is for the Buyer's own use and the Buyer undertakes that the said Fuel Oil will not be resold or exchanged.

**7. FORCE MAJEURE**

The Seller shall not be responsible for any failure to fulfil any term of this Agreement if fulfilment has been delayed, hindered or prevented by any circumstances whatsoever which is not within the reasonable control of the Seller.

**8. ASSIGNMENT**

This Agreement shall not be assigned or transferred by the Buyer directly or indirectly without the written consent of the Seller.

**9. The Data Protection (Bailiwick of Guernsey) Law 2017**
